## XXI NORCECA VOLLEYBALL CONFEDERATION CONGRESS 2011 PROCEDURES FOR THE CANDIDATURE PRESENTATION

- 1. Each National Federation or Regional Member Affiliated to NORCECA Volleyball Confederation updated with its responsibilities, with the payment of their annual affiliation fees, is entitled to nominate and present before the Congress the Candidatures for NORCECA President, Board of Administration, Commission Members and Internal Auditors.
- 2. For the presentation before the Congress of the candidate nominated for NORCECA's Presidency, each Affiliated National Federation is entitled to nominate the candidate of its preference, presenting for such candidature a member of one of NORCECA's Affiliated National Federation. The candidate nominated for NORCECA's Presidency must be an active member f the Executive Committee and/or Board of Administration of his/her National Federation.

Additionally, the candidate nominated for NORCECA Presidency should have presided or a member of the Organizing Committee for the Organization in his/her country of a major regional, zonal, interzonal, continental, intercontinental, and international or world competition. (FIVB and/or NORCECA Volleyball and Beach Volleyball Tournaments and Championships)

3. For the presentation before the Congress of the candidate nominated to NORCECA's Board of Administration, each National Federation is entitled to present the candidature of its preference within the members of the Executive Committee and/or Board of Administration of their National Federation. The candidate nominated for NORCECA's Board of Administration must be an active member of the Executive Committee or Board of Administration of his/her National Federation with sufficient decision making power.

Also, the candidate nominated for NORCECA's Board of Administration must have been or actually be an active member in one of NORCECA's Commissions, representing his/her National Federation and/or Zone.

Additionally, the candidate nominated for NORCECA Board of Administration should have presided or a member of the Organizing Committee for the organization in his/her country of a major Zonal, Inter-zonal, regional, continental, intercontinental, competition. (FIVB and/or NORCECA Volleyball and Beach Volleyball Tournaments and Championships)

4. For the presentation before the Congress of the candidate nominated to one of NORCECA's working Commission, each National Federation is entitled to present the candidature of its preference within the members of its National Federation.

The members nominated by their National Federation to one of NORCECA's Working Commission, must fulfill the profile and/or technical requirements specified for each Commission. The requirements established for the nomination of the candidature as member to one of NORCECA's Working Commission are the following:

#### 1. Sport Organizing Commission

The candidate nominated must be an active member of the Executive Committee and/or Board of Administration of his/her National Federation with sufficient decision making power.

#### 2. Beach Volleyball Commission

Must be an active member of its National Federation, preferable developing his/her activities in Beach Volleyball National Competitions, with sufficient decision making power.

#### 3. NORCECA Medical Commission

Must be an active member of its National Federation, as well as a professional and active Doctor in medicine (MD) preferably, with a degree in Sport Medicine and must be registered as a Doctor by the Federation Internationale de Volleyball, FIVB.

#### 4. Technical and Coaches Commission

Must be an active member of its National Federation, with a minimum grade of an International FIVB Coach Level II or equivalent. The members must belong to one of the Development or Technical Commissions of his/her National Federation and must have coached a National Team in a Junior or Senior Competition at minimum continental level.

#### 5. Refereeing Commission

Must be an active member of its National Federation, having been an International FIVB Referee (retired). The candidate must preside and/or be a member of the Refereeing Commission of his/her National Federation.

#### 6. Press and Mass Media Commission

Must be an active member of its National Federation, belonging and/or working preferably with one of the main newspaper of national media communication in his/her country, as well as, television or radio, being registered as Press Officer of his/her National Federation before NORCECA Volleyball Confederation and/or FIVB.

#### 7. Marketing Commission

Must be an active member of its National Federation, as well as, a professional with a degree in marketing and/or publicity, being active as a professional in his career, assisting and cooperating with his/her National Federation in marketing, publicity and obtaining sponsorship for Volleyball and Beach Volleyball events that are held in his/her country.

#### 8. Finance Commission

Must be an active member of its National Federation, as well as, a professional with a degree in Business Administration, Accounting, Economist and/or Finances in his/her country, preferably, must be the treasurer of his/her National Federation and active as a professional in his/her career, working in the private or public sector in his/her country.

#### 9. Legal Commission

Must be an active member of its National Federation, as well as, a professional with a Law degree (attorney at Law), expert in Law in his/her country, preferably must be an attorney at law of his/her National Federation and active as a professional in his/her career working in the private or public sector in his/her country.

#### 10. VIS Commission

Must be an active member of his/her National Federation with a minimum degree in Computing Technician, or equivalent, preferably Engineer in Computer System, member of one of the Technical or VIS Commission in his/her National Federation, must have worked as a Delegated or member of the VIS Sub Commission in a zonal, inter-zonal, regional, continental, intercontinental, international or world competitions. (FIVB and/or NORCECA Volleyball and Beach Volleyball Tournaments and Championships)

Note 1: The members of his/her National Federations that Belongs to a Commission of the Federation Internationale de Volleyball, FIVB, will automatically be a member of his/her similar commission of NORCECA Volleyball Confederation.

Note 2: The candidature presentation must be accompanied by the professional curriculum and sport curriculum and sport history of the candidate. The sport history of the candidate must include a detailed information of the activities developed in their National Federation and for the development of Volleyball and Beach Volleyball in there country. All nominated candidates must be recognized social and moral status in his/her country.
