The USA-1 team of Emily Day and Heather Hughes went undefeated against their U.S. compatriots, beating the USA-2 team of Michelle Moriarty and Kaitlin Sather, 2-0 (21-8, 21-14) and the USA-5 team of Stevi Robinson and Eve Ettinger, 2-0 (21-8, 21-11) in Pool D.
