# REGISTRATION & IMPORTANT INFORMATION FIVB 39th WORLD CONGRESS

Dear President,

We would like to share some important information regarding the 39<sup>th</sup> World Congress which will be held in the city of **Porto, Portugal, from 15<sup>th</sup> to 17<sup>th</sup> November 2024**.

The congress will take place at the Sheraton Hotel in Porto, Portugal. However, official Congress accommodation will be the Sheraton Hotel and the Crowne Plaza Hotel. Both hotels are only located at 3-minute walk (230 meters) away from each other. The hotel assignation will be done by the congress secretariat depending on the arrival/ departure dates and room type selected at registration.

Once again this year, we are pleased to exceptionally offer a single room to the first delegate of each National Federation. His board and lodging will be covered by the FIVB from the official arrival date (14 November) to the official departure date (18 November).

The FIVB will be pleased to reserve and pay for the air ticket in economy class for the first delegate of National Federations in Categories 1 & 2.

Your username and password are the credentials used for your VIS account.

To help you fill in the required information regarding your accommodation, please read the following, which is valid from the official arrival date (14 November) to the official departure date (18 November):

- 1<sup>st</sup> delegate board and lodging in a single room (exceptionally this year again) will be paid by the FIVB
- 2<sup>nd</sup> delegate all costs to be paid by the NF (if you need an additional single room or if you would like to share the room with the 1<sup>st</sup> delegate of your NF)
- Interpreter (for non-official languages) all costs to be paid by the NF (there will be simultaneous interpretation in English, French, Spanish, Russian, Arabic & Portuguese)
- > Guest; spouse & family all costs to be paid by the NF

Only 2 delegates (and an interpreter if necessary for non-official language) will be allowed to enter the Congress Hall for logistical reasons.

## **Payment**

Once your NF registration(s) have been verified by the Congress Secretariat, you will receive a payment link to settle the balance (if any). The invoice will have to be paid before the arrival day.

## Credential letter & Proxy letter

The credential letter and proxy letter templates are attached to this document and can be also downloaded from the registration platform.

You are kindly requested to upload your credential letter (or your proxy letter <u>only if you cannot attend</u>) in the online platform.

Please attach proof to this Credential Letter that the delegate(s) is/are a member of the NF's Board or holds an official position in the NF as well as proof that he is a national or permanent resident of the country concerned.

Moreover, please note that we still **need to receive your original credential letter duly signed by the President and the Secretary General** by post mail as usual to the address: *FIVB, Congress Secretariat, Chemin Edouard-Sandoz 2-4, 1006 Lausanne, Switzerland.* 

#### **Visas**
