## **NOTE 1. Organization**

The North, Central American and Caribbean Volleyball Confederation, NORCECA, is a non-profit, non-governmental, Multinational and Continental Organization affiliated to the Federation Internationale de Volleyball, FIVB, founded on April 20, 1947, in Paris, France. The FIVB consists of 222 affiliated National Federations whose mission is the worldwide management and guidance of volleyball and beach volleyball in their respective countries and/or territories. The FIVB's Central Headquarters is located in the city of Lausanne, Switzerland.

The FIVB has grouped its affiliated National Federations into 5 Confederations, taking into consideration their geographical location:

- African Confederation
- Asian Confederation
- European Confederation
- North, Central American and Caribbean Confederation
- South American Confederation

NORCECA's objective is the management, organization, representation, regulation, control and evaluation of all volleyball and beach volleyball activities in the North, Central American and Caribbean Regions to support and facilitate the development of its affiliated National Federations, guaranteeing that the FIVB Constitution, Administrative, Financial, Sport, General Regulations and Disciplinary are met.

The FIVB Board of Administration must approve the Constitution, Regulations and decisions of the NORCECA Volleyball Confederation as a representative body of the FIVB. Also, NORCECA must guarantee full commitment to the general principles and guidelines of the FIVB. NORCECA was recognized as a Continental Confederation by the FIVB in 1968. The new elected authorities of NORCECA were transferred to the Dominican Republic on November 1st, 2001 and were re-elected during the XXIII NORCECA Congress 2015 and will remain for a period of 4 years until October 23rd, 2019. Mr. Cristobal Marte Hoffiz, President, represents NORCECA.

The majority of NORCECA's income comes from the FIVB annual contribution, competitions, events and activities, publicity, marketing rights and National Federation affiliation fees. As of December 31st, 2017 a total of 41 National Federations and Regional members are affiliated to the NORCECA Volleyball Confederation. The NORCECA Headquarters are located at Av. Máximo Gomez, Esquina 27 de Febrero, Volleyball Pavilion, Juan Pablo Duarte Olympic Center in the city of Santo Domingo, Dominican Republic.

## **NOTE 2. Accounting Policies**

### **2.1 Income**

NORCECA accounting policies recognizes its income using the accrual method.

### **2.2 Foreign Currencies**

Transactions in foreign currencies are converted into the local currency of Dominican Pesos (RD), according to the current exchange rate at the time of the transaction. Profit and loss resulting from the transaction of foreign currencies are included in the Profit and Loss Statement.

As of December 31st 2017, the current exchange rate for the US\$ dollar used by NORCECA Confederation, was RD\$48.19 per US\$1.00 and the exchange rate for the Swiss Franc was RD\$49.39. por CHF1.00

### **2.3 Furniture and Equipment**

Furniture and equipment are registered at the acquisition cost.

The depreciation is calculated using the straight line method at an annual rate of 25% and 15%





## **NOTE 2. Accounting Policies**

### **2.1 Income**

NORCECA accounting policies recognizes its income using the accrual method.

### **2.2 Foreign Currencies**

Transactions in foreign currencies are converted into the local currency of Dominican Pesos (RD\$), according to the current exchange rate at the time of the transaction. Profit and loss resulting from the transaction of foreign currencies are included in the Profit and Loss Statement.

As of December 31st, 2017 and 2016 the current exchange rate for the US\$ used by NORCECA Volleyball Confederation is RD\$48.19 y RD\$49.39 and for the Swiss Franc is RD\$46.62 y RD\$45.47 respectively.

### **2.3 Furniture and Equipment**

Furniture and equipment are registered at the acquisition cost.

The depreciation is calculated using the straight line method at an annual rate of 25% and 15%


## TOTAL INVESTMENT BY ZONAL ASSOCIATION 2010 -2017




# NORCECA FINANCIAL EVOLUTION 2001- 2017









# ***INTERNAL AUDIT REPORT***

**Internal Auditors Management Report**

We have reviewed the Balance Sheet, the Statement of Activities (profit and Loss account) of NORCECA Volleyball Confederation for the period ended December 31<sup>st</sup> 2017 and the budget for 2018 and 2019. It is our opinion that the Financial Statements reflect a true and fair view of the Financial Position of the Confederation.

Our review of the Financials for 2017 considered the following:

**External Auditors Management Letter**

We reviewed the External Auditors Management Letter for NORCECA Volleyball Confederation for the Financial Year Ended December 31<sup>st</sup> 2016.

The Management letter documented some similar recommendations of the Internal Auditors prior years Reports:-

- NORCECA should have written contracts for NORCECA staff as required by the Dominican Labor laws.
- The provision for accounts receivable policy and procedures. NORCECA indicated that the current policy is for receivable over two years. However the policy need to be clearly defined i.e. if it the full amount that is provided or a percentage.
- The absence of an accounting handbook which serve as an important instrument to manage regularly, consistently and on a timely base the financial accounts. The financial handbook should describe the nature of the accounts of the general ledger and the procedures how to register the transactions.
- Risk assessment for the existence of NORCECA that covers both financial and environmental. A matrix identifying each person role and responsible is needed.
- Software upgrade, the need to fully automate the Confederation operating system.
- Formalization of employees Job description and function.

We recommend that the Confederation implement the recommendations of the External Auditors were possible in a timely manner.

#### Income

We noted the significant decrease in income from 2016 to 2017 of RD\$(34.5M) mainly due to the "modification" of the Financial Allowances from FIVB to the Confederations for 2016 resulting in no 2016 funds being disbursed to all Confederations. Basically what was received for the 2017 period (USD 613,626) was to apply to the operating expenses 2017. We noted the change in the currency type in which the funds were received from Swiss Franc to USD. This was evident by correspondence received from FIVB.

In addition, we also saw communication from FIVB documenting a reduction in the 2018 Financial Allowance to 66% (USD 404,993) of the amount paid in 2017 (USD 613,626). This decline in Financial Allowance from FIVB possess a significant risk in the operations of NORCECA, whom have relied on a fixed Financial Allowance from FIVB of Swiss Franc 750,000 over the last four years.

We have seen that the impact of the reduction in this Financial Allowance from FIVB significantly affected the development plans in the NORCECA region. The impact will pass down to the various National affiliates of NORCECA impeding the existing growth and development of the game that we have seen within the NORCECA Region over the pass years.

#### Uncollectible Accounts

With the non-payment of FIVB financial allowance funds for 2016 NORCECA has recorded this as an expense "uncollectible accounts" in the Statement of Activities year ended December 31<sup>st</sup> 2017.

The Internal Auditors will like to suggest that this transaction is treated as a "bad debt" provision in the interim until External Auditors completes the 2017 audit.

#### Previous Years Internal Audit Reports

We examined and interviewed the NORCECA Treasurer regarding the previous year's internal audit suggestions. It was stated that the Confederation was unable to implement the Internal Audit suggestions based on limited resources with the exception of the account receivable provision. Our previous year's suggestions are as follows:


1. Both the External and internal auditors suggested the upgrade of the accounting system to a fully automated accounting system in keeping with the size of the organisation. This has not been addressed to date.
2. The internal Auditors and Board of Directors suggestion a third person be included on the bank signatories. This has not been done to date.

3. We noted no provision has still not been made in the accounting records for Severance Liability notwithstanding that Dominican Labor Code that requires the payment of severance to employees based on several types of termination including death of an employee.
4. The Internal Auditors suggested a Mid-year review of the operations of NORCECA along with the Treasurer. This too was not implemented. Given the reduction in Financial Allowance, such an exercise becomes more critical to maintain firm control on the Confederation operating activities.
5. We also suggested the documentation of accounting procedures to which at the Finance committee meeting 2017, the Treasurer and member of the Finance Committee agreed to assist in drafting the document. This has started with the accounts receivable.
6. The High risk of accounting system Back up. There is a primary person assigned to execute the accounting back up daily. A secondary person needs to be assigned to perform the back up in the absence of the primary person.
7. Actual vs budget variance analyst of transaction with a 10% variance. The suggestion to document the reasons for the 10% variance of actual vs budget will help to assist management in decision making.

The Finance Committee have agreed to seriously undertake to close out these issues within the coming years.

**Conclusion:**

We recognize the new challenges that the Accounting staff of NORCECA Confederation faces with the adhoc changes to the financial allowances received from FIVB from one year to the next. We think it is even more important now to utilize the expert knowledge of the Treasurer of NORCECA and Finance commission Chairman in the day to day operating activities of the office to ensure the Confederation keeps functioning efficiently and effectively.
