## **NOTE 1. Organization**

The North, Central American and Caribbean Volleyball Confederation, NORCECA, is a non-profit, non-governmental Continental Multinational Sports Organization, founded on August 14, 1966 in the city of San Juan, Puerto Rico and consists of 41 National Federations and Affiliate Regional Members, affiliated to the Federation Internationale de Volleyball, FIVB, founded on April 20, 1947, in Paris, France. The FIVB consists of 222 affiliated National Federations grouped in 5 Continental Confederations, whose mission is the management and world guide of Volleyball and Beach Volleyball in their countries and territories. The FIVB Headquarters is located in the city of Lausanne, Switzerland.

The FIVB has grouped its affiliated National Federations into 5 Confederations, taking into consideration their geographical location:

African Confederation

Asian Confederation

European Confederation

North, Central American and Caribbean Confederation

South American Confederation

NORCECA's objective is the management, organization, representation, regulation, control and evaluation of all volleyball and beach volleyball activities in the North, Central American and Caribbean Regions , to support and facilitate the development of its affiliated National Federations, guaranteeing that the FIVB Constitution, Administrative, Financial, Sport, General and Disciplinary Regulations are met.

The FIVB Board of Administration must approve the Constitution, Regulations and decisions of the NORCECA Volleyball Confederation as a representative body of the FIVB. Also, NORCECA must guarantee full commitment to the general principles and guidelines of the FIVB. NORCECA was recognized as a Continental Confederation by the FIVB in 1968. The new elected authorities of NORCECA were transferred to the Dominican Republic on November 1, 2001, during the XVI NORCECA Congress, being reelected during the XVIII NORCECA Congress held in 2005, as well as , during the XXI NORCECA Congress held in 2011 and reelected during the XXIII NORCECA Congress held in 2015. Mr. Cristóbal Marte Hoffiz, President, represents NORCECA.

Norceca income comes from the competitions, events, activities, publicity, marketing rights and National Federation affiliation fees. As of December 31, 2019 a total of 41 National Federations and regional members are affiliated to the NORCECA Volleyball Confederation. The NORCECA Headquarters are located at Av. Máximo Gomez, Esquina 27 de Febrero, Volleyball Pavilion, Juan Pablo Duarte Olympic Center in the city of Santo Domingo, Dominican Republic.

## **NOTE 2. Accounting Policies**

### **2.1 Income**

NORCECA accounting policies recognizes its income using the accrual method.

### **2.2 Foreign Currencies**

Transactions in foreign currencies are converted into the local currency of Dominican pesos (RD), according to the current exchange rate at the time of the transaction. Profits and losses resulting from the transaction of foreign currencies are included in the Profit and Loss Statements.

As of December 31, 2019, the current exchange rate for the US\$ dollar used by NORCECA Confederation was RD\$52.90 per US\$1.00 and the exchange rate for the Swiss Franc was RD\$54.62 per CHF 1.00

### **2.3 Furniture and Equipment**

Furniture and equipment are registered at the acquisition cost.

The depreciation is calculated using the straight line method at an rate of 25% and an 15% annual.

## **NOTE 3. Cash and Bank Balance**

The North, Central American and Caribbean Volleyball Confederation perform its operations through two current bank accounts, registered under the name of NORCECA with the signatures of Lic.





## **NOTE 2. Accounting Policies**

### **2.1 Income**

NORCECA accounting policies recognizes its income using the accrual method.

### **2.2 Foreign Currencies**

Transactions in foreign currencies are converted into the local currency of Dominican Pesos (RD\$), according to the current exchange rate at the time of the transaction. Profit and loss resulting from the transaction of foreign currencies are included in the Profit and Loss Statement.

As of December 31<sup>st</sup> 2019 and 2018 the current exchange rate for the US\$ used by NORCECA Volleyball Confederation is RD\$52.90 and RD\$50.20 and for the Swiss Franc is RD\$54.62 and RD\$51.03 respectively.

### **2.3 Furniture and Equipment**

Furniture and equipment are registered at the acquisition cost.

The depreciation is calculated using the straight line method at an annual rate of 25% and 15%

**Internal Audit Period: Financial Year Ended December 31<sup>st</sup> 2019**

We undertook the internal audit remotely from August 23<sup>rd</sup> to August 26<sup>th</sup> due to the current global pandemic. We took the opportunity to review not only the 2019 financials but also, the operations of NORCECA in terms of the impact of the pandemic and its future operations, particularly current 2020 finances, 2020 budget and 2021 budget.

The global pandemic has presented unforeseen challenges to all organizations and it shows how organizations should become flexible to drastic market and health crisis that will determine the survival of an organization.

We have reviewed the Balance Sheet, the Statement of Activities (profit and loss account) of NORCECA Volleyball Confederation for the period ended December 31<sup>st</sup> 2019 and the budget for 2020 and 2021; and we have relied on the opinion expressed by the External Auditors. It is our opinion that the Financial Statements reflect a true and fair view of the Financial Position of the Confederation.

Nonetheless, the Internal auditors strongly recommend that NORCECA be more receptive to making adjustments to the budgets as events may warrant it, as it is the case for 2020, 2021 and even the following five years. It is generally good practice that budgets be revised in the first six months of any given fiscal year when major internal or external developments occur, which could have an impact on an institution's operational and financial performance.

It will also be a good practice to prepare mid year financial statements to be used internally by NORCECA to assist in future projections planning and aid in decision making.

With regards to the 2019 Audit we reviewed the balance sheet in particular the receivables and payables to identify if these costs have been updated in 2020. We also reviewed the Income and Expenditure and reports as follows:

1. Receivables from national federations: we enquire as to the possibility of Norceca receiving these outstanding funds from Guatemala, Puerto Rico and Suriname. It was reported that these territories are paying as they can pay, the cost was incurred based on events held and sponsors did not honor their commitment.


2. Receivable from the Organizing committee of Tokyo (US\$ 102,070), given the postponement of the 2020 Olympics, has been received in 2020.
3. Payables related to athletes transfer since 2012/2013 to FIVB are still outstanding; this is due to reduced funds received from FIVB.
4. The payment in advance for Congress 2020, Norceca have received a credit for future bookings.

#### **2020 budget**


Given the current situation we enquired what steps have been taken during the pandemic to keep NORCECA alive, we were advised that the staff was cut by 50% and expenditure by 80%.

#### **Conclusion:**

The occurrences of 2020 have forced organizations to adopt rapidly for survival. It forces NORCECA operations to evolve in these challenging times and continue to utilize the knowledge and expertise of Treasurer of NORCECA and other Board members.
