NOTES AND ACCOUNTING POLICIES

FINANCIAL REPORT 2021

NOTA 1. Organización

The North, Central American and Caribbean Volleyball Confederation, NORCECA, is a non-profit-non-governmental Continental Multinational Sport Organization, founded on August 14, 1966 in the city of San Juan, Puerto Rico and consist of 41 national federations and affiliate regional members, affiliated to the Federation Internationale de Volleyball, FIVB founded on April 20, 1947, in Paris, France. The FIVB consist of 222 affiliated national federations grouped in 5 continental confederations, whose mission is the management and world guide of Volleyball and Beach Volleyball in their countries and territories. The FIVB headquarters is located in the city of Lausanne, Switzerland.

The FIVB has grouped its affiliated National Federations into 5 Confederations, taking into consideration their geographical locations:

- *African Confederation
- *Asian Confederation
- *European Confederation
- *North, Central American and Caribbean Confederation
- *South American Confederation

Norceca objective is the management, organization, representation, regulation, control and evaluation of all volleyball and beach volleyball activities in the North, Central American and Caribbean Regions, to support and facilitate the development of its affiliated National Federations, guaranteeing that the FIVB Constitution, Administrative, Financial, Sport, General and Disciplinary Regulations are met.

The FIVB Board of Administration must approve the Constitution, Regulation and decisions of the NORCECA Volleyball Confederation as a representative body of the FIVB. Also, NORCECA, must guarantee full commitment to the general principles and guidelines of the FIVB. NORCECA was recognized as a Continental Confederation by the FIVB in 1968. The new elected authorities of NORCECA were transferred to the Dominican Republic on November 1, 2001, during the XVI NORCECA Congress, being reelected during the XVIII NORCECA Congress held in 2005, the XXI NORCECA Congress held in 2011, the XXII NORCECA Congress held in 2015 and reelected during the XXV NORCECA Virtual Congress held in 2020. Mr. Cristobal Marte Hoffiz, President, represents NORCECA.

NORCECA Income comes from the competitions, events, activities, publicity, marketing right and National Federation affiliation fees. As of December 31, 2021 a total of 41 National Federations and regional members are affiliated to the NORCECA Volleyball Confederation, The NORCECA Headquarters are located at Av. Maximo Gomez, Esquina 27 de febrero, Volleyball Pavilion, Juan Pablo Duarte Olympic Center in the city of Santo Domingo, Dominican Republic.

NOTE 2. Accounting Policies

2.1 Income

NORCECA accounting policies recognize its income using the accrual method

2.2 Foreign Currencies

Transactions in foreign currencies are converted into the local currency of Dominican pesos (RD), according to the current exchange rate at the time of transaction, profits and losses resulting from the transaction of foreign currencies are included in the Profit and loss Statements.

As of December 31, 2021 the current exchange rate for USD\$ dollar used by NORCECA Confederation was RD\$57.14 per USD\$1.00 and the exchange rate for the Swiss Franc was RD\$62.45 per CHF1.00

2.3 Furniture and Equipment

Furniture and Equipment are registered at the acquisition cost.

The depreciation is calculated using the straight-line method at an rate of 25% and an 15% annual.

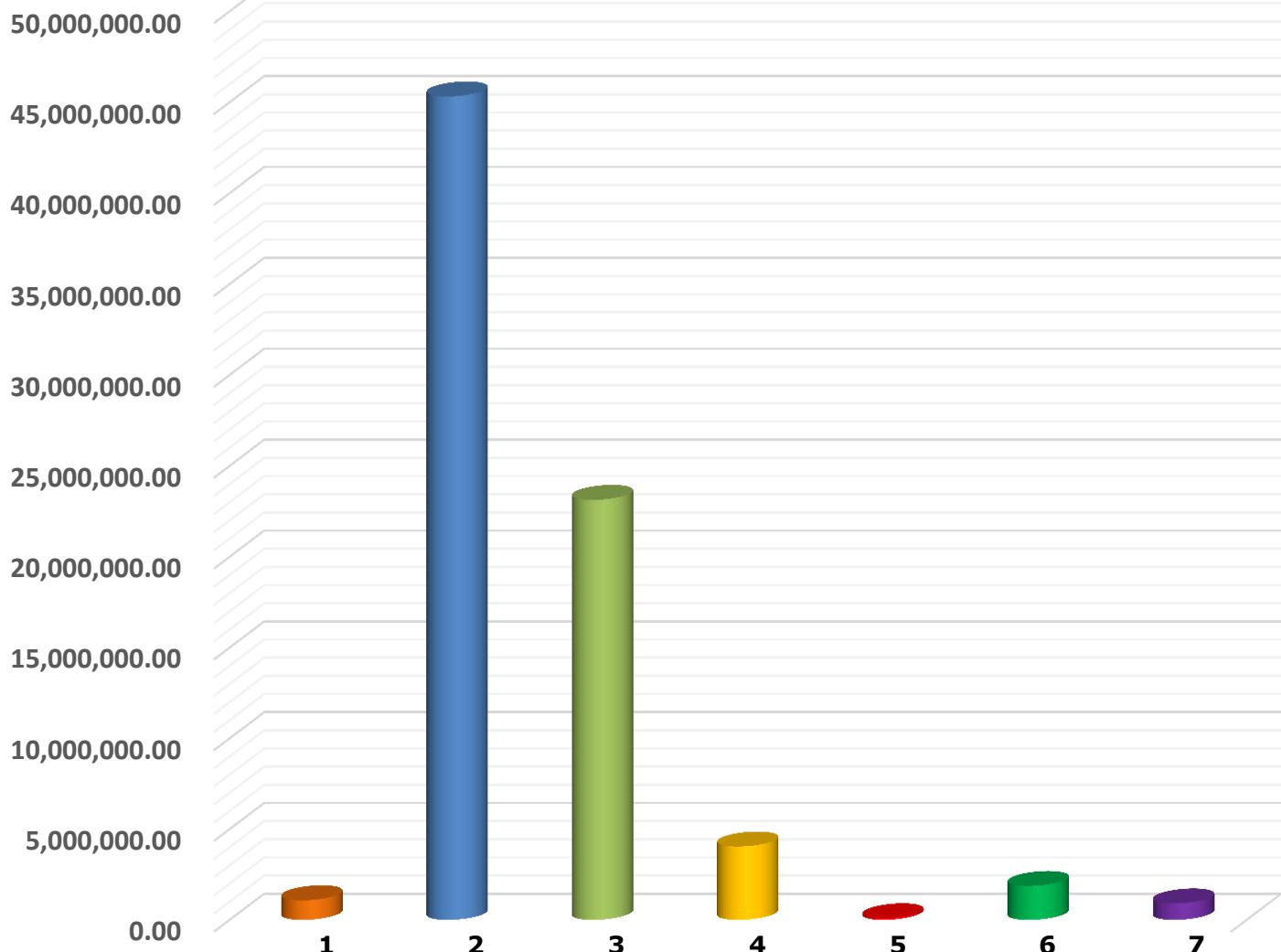

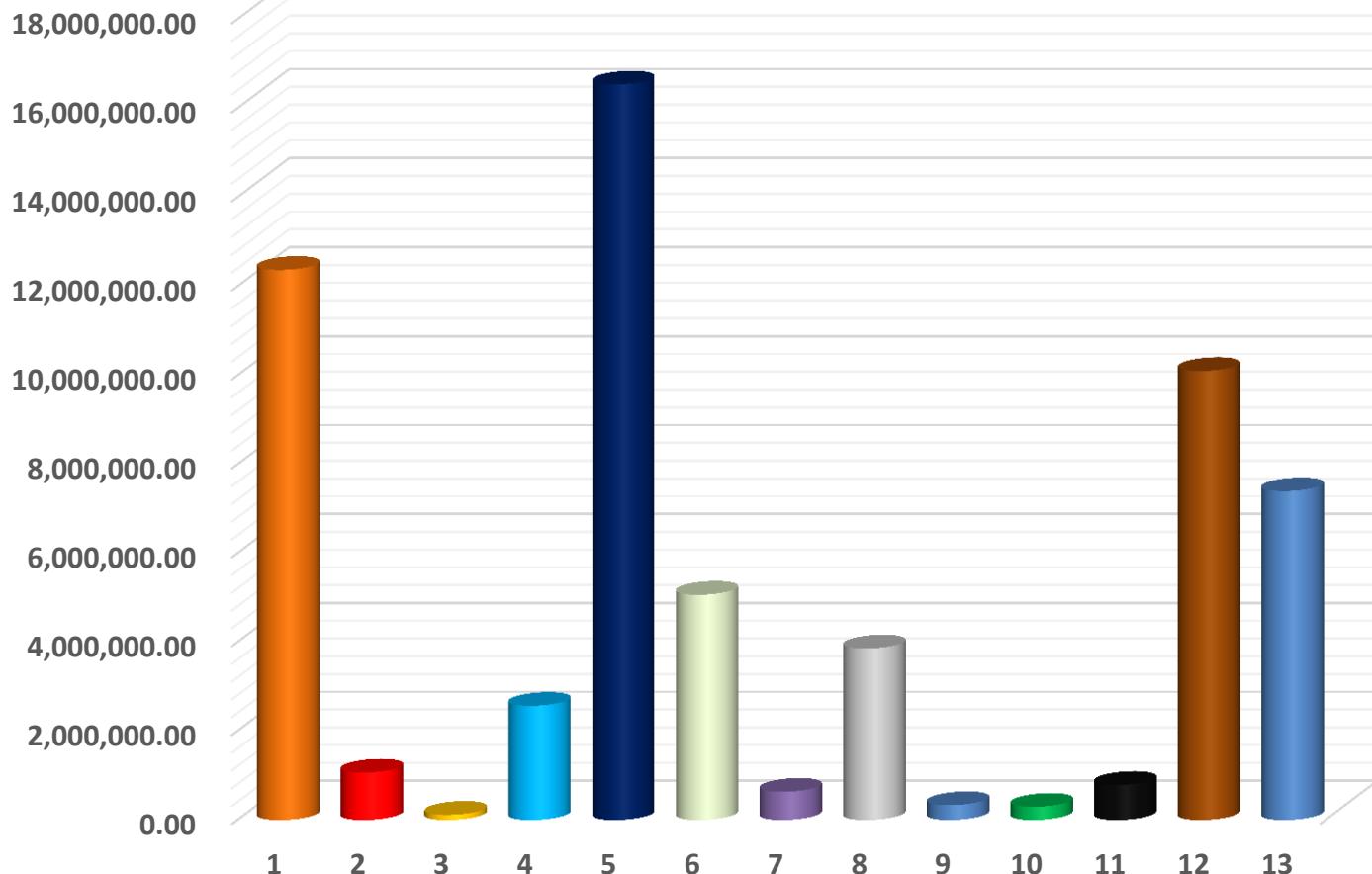

NOTE 2. Accounting Policies

2.1 Income

NORCECA accounting policies recognizes its income using the accrual method.

2.2 Foreign Currencies

Transactions in foreign currencies are converted into the local currency of Dominican Pesos (RD\$), according to the current exchange rate at the time of the transaction. Profit and loss resulting from the transaction of foreign currencies are included in the Profit and Loss Statement.

As of December 31st 2021 and 2020 the current exchange rate for the USD\$ used by NORCECA Volleyball Confederation is RD\$57.14 and RD\$58.11 and for the Swiss Franc is RD\$65.81 and RD\$62.45 respectively.

2.3 Furniture and Equipment

Furniture and Equipment are registered at the acquisition cost.

The depreciation is calculated using the straight-line method at an annual rate of 25% and 15%.

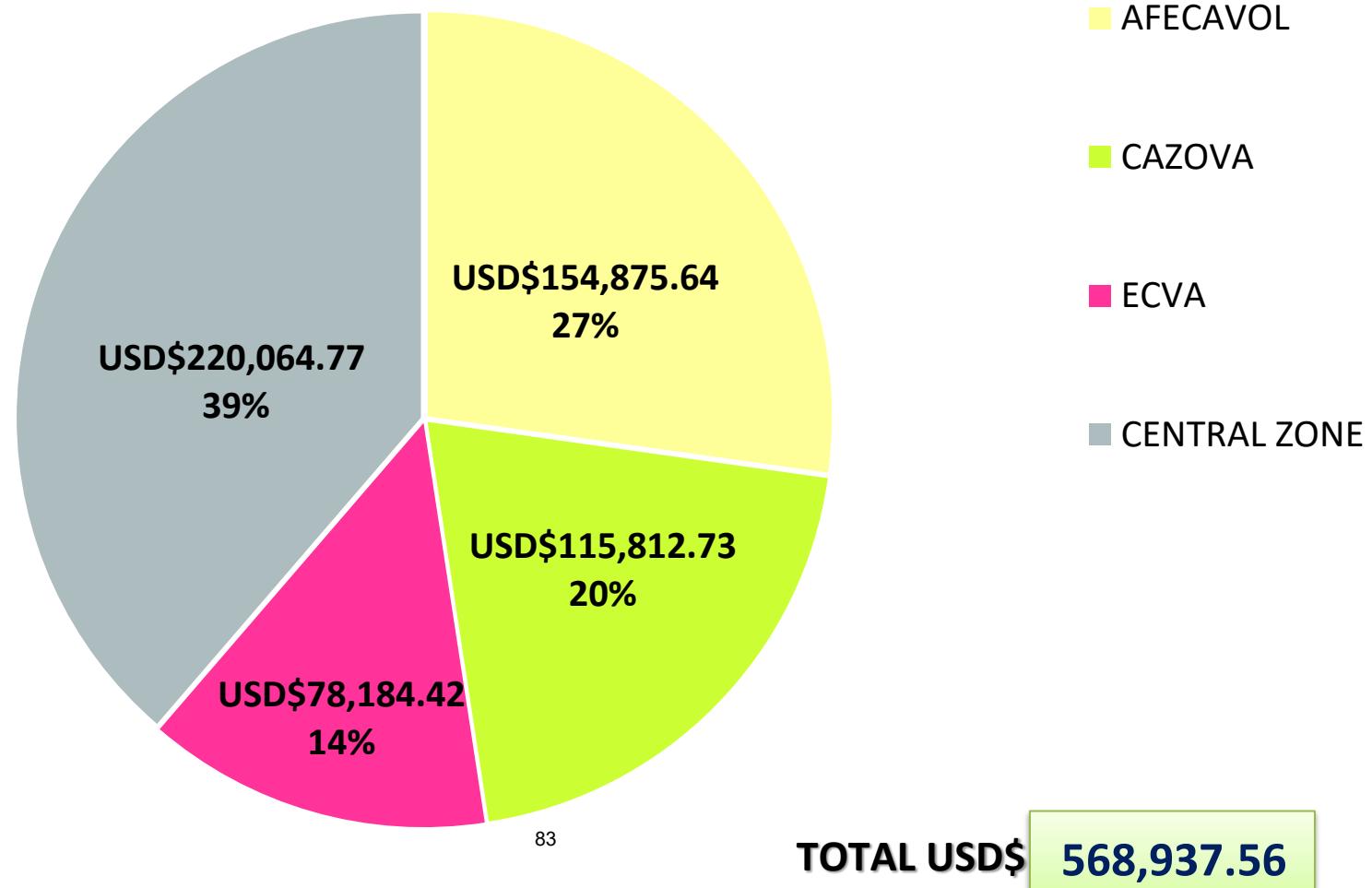

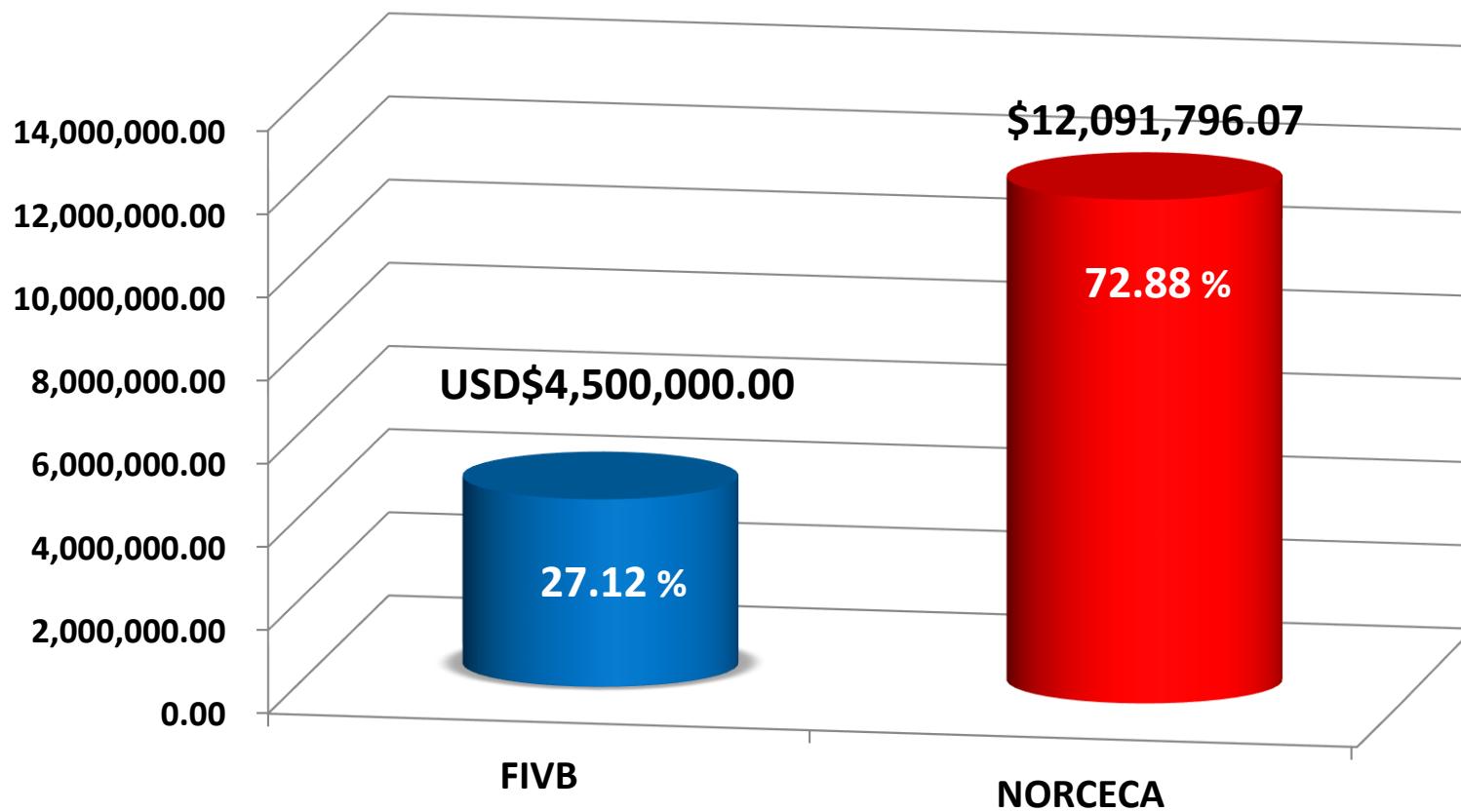


CONGRESS, ASSEMBLIES, MEETINGS AND OTHER EXPENSES 2010-2021

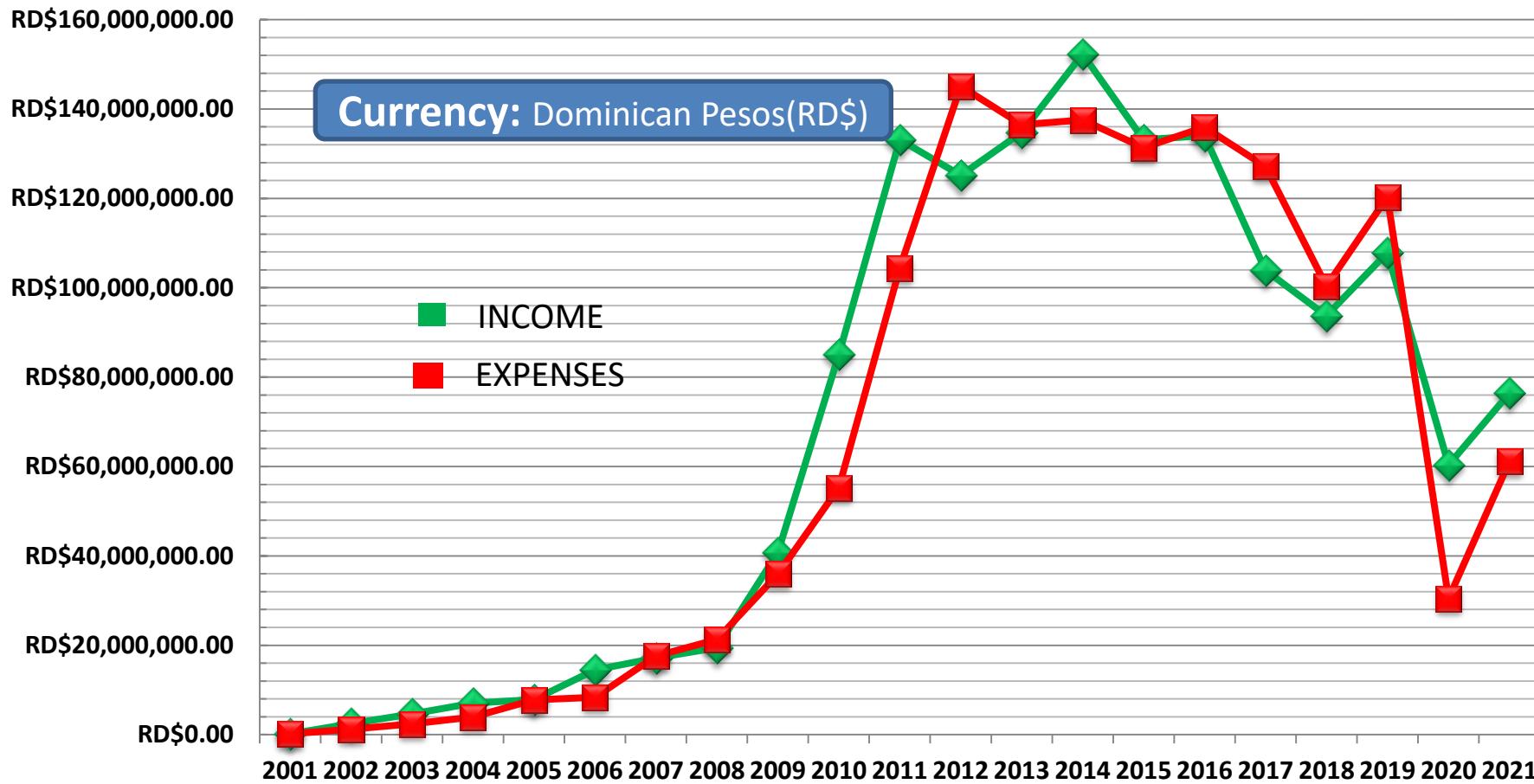








INCOME AND EXPENSES 2001-2021

Budget 2022/2023

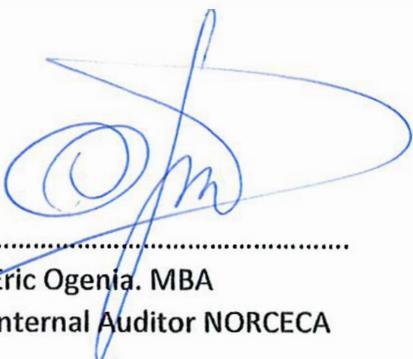
