## **NOTE 1. Organización**

The North, Central American and Caribbean Volleyball Confederation, NORCECA, is a non-profit-non-governmental Continental Multinational Sport Organization, founded on August 14, 1966 in the city of San Juan, Puerto Rico and consist of 41 national federations and affiliate regional members, affiliated to the Federation Internationale de Volleyball, FIVB founded on April 20, 1947, in Paris, France. The FIVB consist of 222 affiliated nacional federations, grouped in 5 continental confederations, whose mission is the management and world guide of Volleyball and Beach Volleyball in their countries and territories. The FIVB headquarters is located in the city of Lausanne, Switzerland.

The FIVB has gruoped its affiliated National Federations into 5 Confederations, taking into consideration their geographical locations:

- \*African Confederation
- \*Asian Confederation
- \*European Confederation
- \*North, Central American and Caribbean Confederation
- \*South American Confederation

Norceca objective is the management, organization, representation, regulation, control and evaluation of all volleyball and beach volleyball activities in the North, Central American and Caribbean Regions, to sopport and facilitate the development of its affiliated National Federations, guaranteeing that the FIVB Constitution, Administrative, Financial, Sport, General and Disciplinaty Regulations ar met.

The FIVB Board of Administration must approve the Constitution, Regulation and decisions of the NORCECA Volleyball Confederation as a representative body of the FIVB. Also, NORCECA, must guarantee full commitment to the general principles and guidelines of the FIVB. NORCECA was recognized as a Continental Confederation by the FIVB in 1968. The new elected authorities of NORCECA were transferred to the Dominican Republic on November 1, 2001, during the XVI NORCECA Congress, being reelected during the XVIII NORCECA Congress held in 2005, the XXI NORCECA Congress held in 2011, the XXII NORCECA Congress held in 2015 and reelected during the XXV NORCECA Virtual Congress held in 2020. Mr. Cristobal Marte Hoffiz, President, represents NORCECA.

NORCECA Income comes from the competitions, events, activities, publicity, marketing righth and National Federation affiliation fees. As of December 31, 2023 a total of 41 National Federations and regional members are affiliated to the NORCECA Volleyball Confederation, The NORCECA Headquarters are located at Av. Maximo Gomez, Esquina 27 de febrero, Volleyball Pavilion, Juan Pablo Duarte Olympic Center in the city of Santo Domingo, Dominican Republic.

## NOTE 2. Accounting Policies

### 2.1 Income

NORCECA accounting policies recognize its income using the accrual method

### 2.2 Foreign Currencies

Transactions in foreign currencies are converted into the local currency of Dominican pesos (RD), according to the current exchange rate at the time of transaction, profits and losses resulting from the transaction of foreign currencies are included in the Profit and loss Statements.

As of December 31, 2023 the current exchange rate for USD\$ dollar used by NORCECA Confederation was RD\$57.83 per USD\$1.00 and the exchange rate for the Swiss Franc was RD\$62.19 per CHF1.00

### 2.3 Furniture and Equipment

Furniture and Equipment are registered at the acquisition cost.

The depreciation is calculated using the straight-line method at an rate of 25% and an 15% annual.

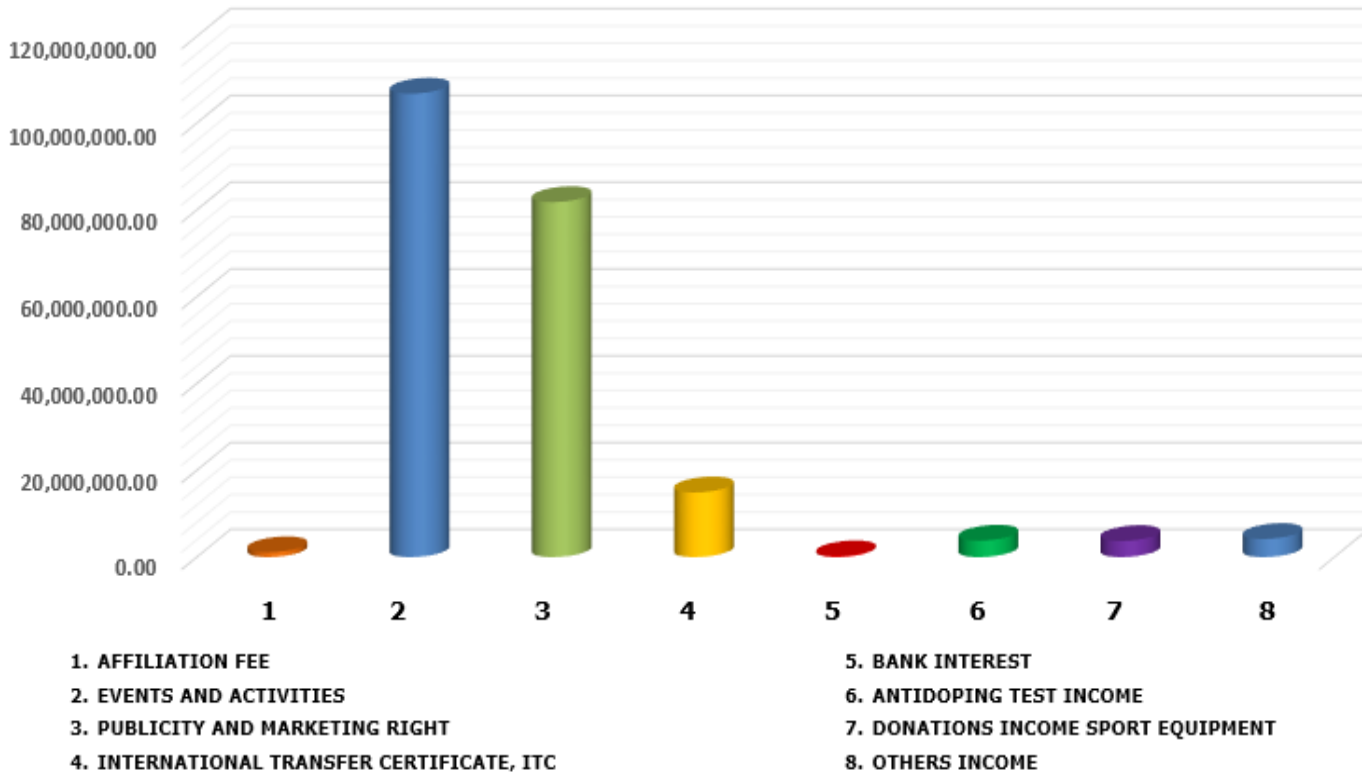

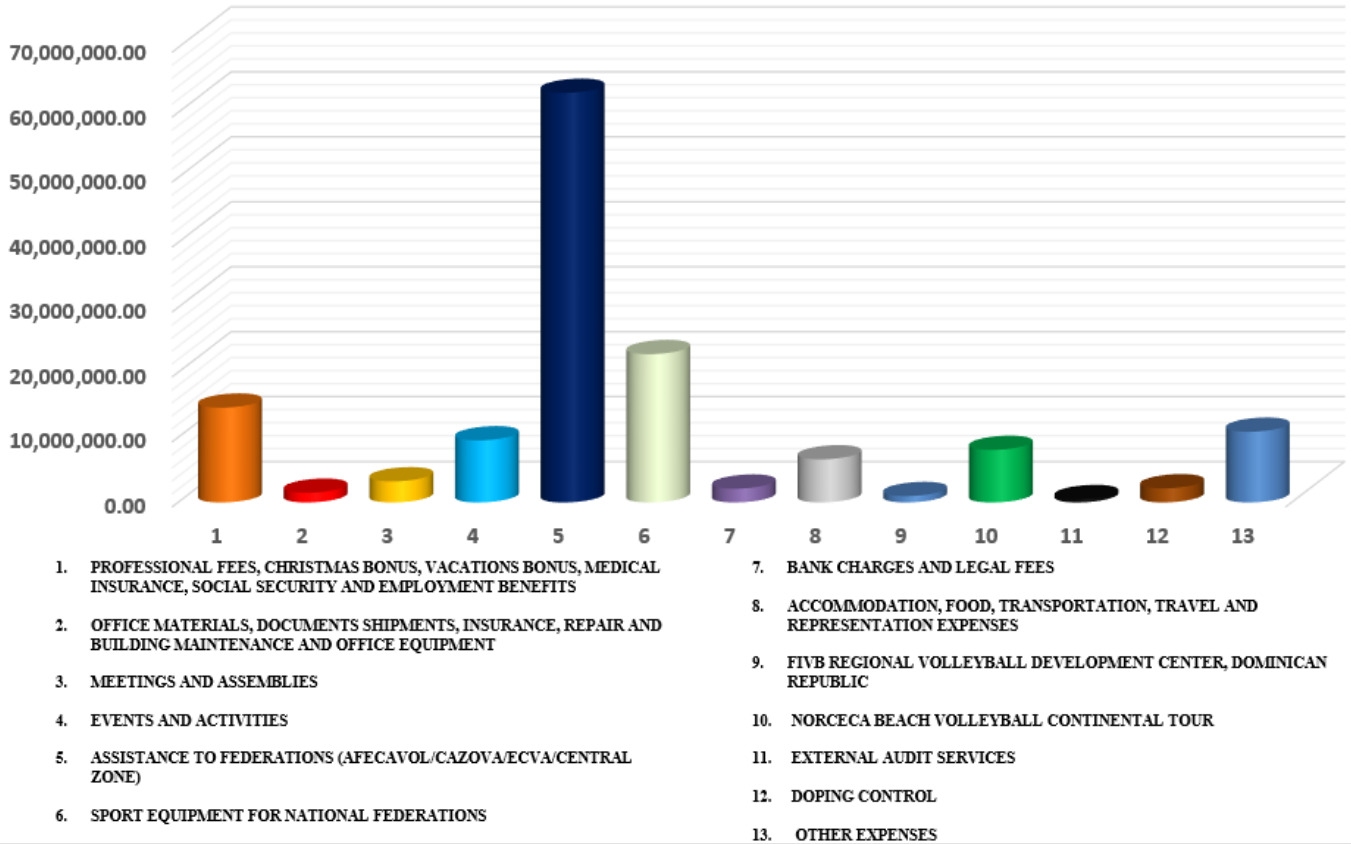

## NOTE 2. Accounting Policies

### 2.1 Income

NORCECA accounting policies recognizes its income using the accrual method.

### 2.2 Foreing Currencies

Transactions in foreign currencies are converted into the local currency of Dominican Pesos (RD\$), according to the current exchange rate at the time of the transaction. Profit and loss resulting from the transaction of foreign currencies are included in the Profit and Loss Statement.

As of December 31st 2023 and 2022 the current exchange rate for the USD\$ used by NORCECA Volleyball Confederation is RD\$57.83 and RD\$55.98 and for the Swiss Franc is RD\$60.62 y RD\$62.19 respectively.

### 2.3 Furniture and Equipment

Furniture and Equipment are registered at the acquisition cost.

The depreciation is calculated using the straight-line method at an annual rate of 25% and 15%.

### **Internal Audit Period: Financial Year Ended December 2023**

We undertook the internal audit remotely and we have reviewed not only the 2023 financials but also 2024 budget and 2025 budget.

We have reviewed the Balance Sheet, the Statement of Activities (profit and loss account) of NORCECA Volleyball Confederation for the period ended December 31st 2023 and the budget for 2024 and 2025 and it is our opinion that the Financial Statements reflect a true and fair view of the Financial Position of the Confederation.

### **Accounts Receivable**

Analyzing both the Account receivables from Affiliated and the account receivables from others we can conclude that those are being monitoring perfectly by Norceca head office.

### **Accounts Payable**

We are completely satisfied with the management Accounts payables of Norceca.

### **Sport Equipment Inventories**

The inventory of materials needs special attention. The inventory of materials is per December 31st 2023 approximately 54 % of the total assets. We were not able to obtain information of the Inventory as per the end of May 2024 as only at the end of the year a physical inventory checking is taken place.

Although Norceca's president has informed all regional president in February that the materials are ready for distribution but still the distribution to a certain group of members goes hand on



hand with some logistical problems. These create excess inventory costs:

- excess inventory creates storage issues and storage space.
- The risk of excess is that inventory does not last forever.
- Items will degrade and lose their value over time there for the distribution should take place in a speedy manner.

From the answers we understood that NORCECA does not possess an inventory system on hand so that at any moment the inventory of materials can be monitored and tracked.

### **Statement of Activities**

#### **Corresponding Year 2023.**

The Income of NORCECA has increased by 138%, while the costs increased by 57%. The main factor for the increase in the income is that Norceca is undertaking various activities to obtain income to cover the loss of the funding from FIVB. As NORCECA increases more activities to generate more income it's important that there are increase monitoring of the cost and income. We suggest that each fund-raising activity is manage and monitor independently.


#### **Budget 2023 versus executed 2023**

In analyzing this section, we have noticed that for Publicity & Marketing the discrepancies between budget figures and actual figures are enormous. The budgeted figures are much higher than the actual figures. We suggest that when preparing the budget to use more realistic assumptions to calculate the budgeted figures.

Conclusion:

Given the financial result of 2023, we again, recommend a regular thorough analysis of both the income and cost be undertaken at least by mid-year, so corrective actions can be taken expeditiously.
