WE, THE UNDERSIGNED, HEREBY AGREE TO TAKE PART IN THE ABOVE-MENTIONED FIVB COMPETITION.
WE DECLARE TO RECOGNIZE THE EXCLUSIVE COMPETENCE OF THE FIVB, ITS OFFICIALS, ITS ORGANS AND ANY JURISDICTIONAL ORGANS THE FIVB MIGHT WISH TO RECOGNIZE AND WE AGREE TO THE PROVISIONS OF ITS RULES AND REGULATIONS IN THE SOLVING OF ANY DISPUTE ARISING FROM THE ABOVE-MENTIONED COMPETITION. THE DECISION RENDERED BY THESE ORGANS, PURSUANT TO THE POWERS GRANTED BY THE FIVB RULES AND REGULATIONS, SHALL SETTLE THE DISPUTE DEFINITELY AND EXCLUSIVELY.

WE, THE UNDERSIGNED, WAIVE THE RIGHTS OF ANY RECOURSE TO CIVIL COURTS AGAINST THE FIVB, ITS OFFICIALS, ITS ORGANS AND THOSE THE FIVB HAS RECOGNISED AND IN RELATION WITH THE DECISION RENDERED BY THESE ORGANS ON THE SAID DISPUTE.
